Finance

Action Item:

Finance Update

The EC Treasurer provided an overview of the 2019 end-ofyear report, at the end of which the following was decided:

Action item:

 Add a meeting agenda item for BOT to have the different reserve categories identified and try to consolidate them with main items in the budget (BOT).

The amount of \$13,200 was approved for Religious Affairs. A one-time security expense of \$30,000 to include installation of high-resolution cameras that allow license plate capture was also approved.

Budget

The motion to adopt the 2020 IFN Budget at \$580,600 was moved and seconded. **There were no objections**. **Motion approved**.

IFN Clinic Bylaws

The motion to approve the clinic bylaws as presented in the board meeting and emailed on 3/7/2020 was moved and seconded. **There were no objections**. **Motion passed**.

IFN Youth Strategy Proposal

A proposal for Youth Strategy and Improvement was presented to the board. This strategy will be aligned with the overall IFN Strategic Plan.

Lead board member will work with appropriate resources to create the pilot group.

Engaging Different Ethnicities
