Story of Kalief Browder




- Charged with stealing a backpack
- Bail amount = \$10,000
- His family was unable to raise the money, so he was sent to Rikers Island.
- He was imprisoned for the next three years

Be Labelled “Criminal” and Go Home, or Face 15 Years in Jail



- Couldn't afford an attorney
- Spent 33 months in Rikers island
- Offered a plea deal

Tortured For Over Two Years of Isolation



- Prisoners are held in a featureless cell
- 23 out of 24 hours each day
- A Punishment Feared by All Prisoners
- The Stanford Prison Experiment showed that psychologically healthy individuals could become sadistic when placed in a prison-like environment.

A Future Down the Drain



- A criminal record can alter the entire course of a person's life

How is 15 years an “appropriate” punishment to threaten a teenager with for the theft of a forty dollar backpack?



God's Mercy and Applying the Hudud Punishments

- “Ward off the hudud as much as you all can, and if you find a way out for the person, then let them go. For it is better for the authority to err in mercy than to err in punishment.” (Early Muslim scholars)

No Bail, Less Hope

- About two-thirds of America's jail population — 450,000 people — are behind bars awaiting trial. And five out of six of those people are in jail because they could not afford bail**

Mujahid's Story





He had to endure more hardship than usual because he crossed racial lines to convert since he is white and the prison Muslim population is predominantly black and latino. Prior to his conversion, he had been engaged in extremely nefarious activities. As a new convert, Mujahid found Tayba Foundation and persevered in his religious studies. He stayed in constant contact with Tayba's instructors and transformed completely, becoming a beautiful example of human excellence.

His before and after pictures tell a story of their own. The first is a picture of a menace to society, and the second is of a benefactor who is preparing himself to inherit his contributory role in building his community and society. This is the Tayba way.


